Dear Member

I hope that you are well and have been able to enjoy some of the recent good weather.

#### The NHS turns 75! Here's to another 75 years.

On Wednesday 28<sup>th</sup> June the BBC episode of the Repair Shop was dedicated to the 75<sup>th</sup> birthday of the NHS. It featured an item brought in by the former Children's Laureate, Michael Rosen, who was placed in an induced coma and spent seven weeks in intensive care after contracting Covid in 2020. In the episode Michael says: "The NHS was wonderful when it came into existence... my mother had lost a child during the war. They didn't have the care and the medicines around so they had a very emotional attachment to this thing they had always wanted; it was a dream that you could have free health care from the cradle to the grave. It just seemed like a wonderful idea to say that we can all look after each other, these people work for all of us, they combine, work together from all over the world. They come and work for the NHS that's what's powerful about it it's for everyone. We want the NHS to continue for the next 75 years."

On the 5<sup>th</sup> July several representatives of the NHS Retirement Fellowship joined NHS staff, volunteers, politicians, patients and members of the public at Westminster Abbey to commemorate the 75<sup>th</sup> anniversary of the founding of our National Health Service. While the NHS has faced unprecedented challenges over recent years, there is much to be proud of and celebrated and we were honoured to be representing the Fellowship past, present and future.

Marking the 75<sup>th</sup> anniversary of the NHS and the contribution given by our members is very important. NHSRF members and staff have played a key role in planning the 75<sup>th</sup> anniversary events. Several of our members have shared their personal stories and some of these have been featured by national media, as well as on our website, NHS sites in England, Scotland and Wales, and a number of social media feeds. I'd like to thank all our members who have shared their stories as part of the celebrations. I have found it incredibly moving to hear stories of the camaraderie of young nurses running wards and treating diseases that current NHS staff do not encounter, and the ways in which our members paved the way for better rights for female staff in the NHS.

The 75<sup>th</sup> anniversary has been a central theme at three major events in which members and staff have represented the Fellowship at during June and July this year. These are:

- The NHS England and the NHS Confederation Conference in Manchester.
- NHS Scotland Event: Recovery and Renewal in our Health and Care Services; and
- The Bevan Commission conference: 'The Tipping Point; Where next for Health and Care?

These events offer important opportunities for the NHSRF to meet and discuss with NHS policy and decision makers, form partnerships with similar organisations, promote the NHSRF as a membership organisation for all retired health and social care staff, and to demonstrate that the Fellowship operates across the three nations of Britain.

### Happy anniversary NHS Retirement Fellowship

This year is also a very important milestone in the life of the Fellowship as we begin celebrating our own 45<sup>th</sup> anniversary. One of the founding statements of Irene James, founder of the NHSRF, was "A Fellowship for retired people especially if given staff and management support would be clear evidence that the health service was playing a proper part in looking after the interests of staff over the long term and not only during their service days". It seems very appropriate that as we celebrate our 45<sup>th</sup> anniversary with a variety of events across branches and at the AGM and Conference that we start to plan ahead for our next 45 years in order to support our retirees. We have therefore made an important start on this.

"Celebrate the past, live in the moment, prepare for the future." This is the title of our new strategic business plan which will run from 2023 – 2028. The Board of Trustees met together on the 9<sup>th</sup> May to work through it in detail, it was then shared with staff and will be introduced to the wider membership, from the autumn of this year. This is an exciting and ambitious plan that will take time and energy. The first three priorities are:

- a) Communicating and consulting with the membership. The full strategy will be shared with the Members Council in September, then it will be introduced at the first virtual 'coffee drop in' for branch officers in October, and a more detailed presentation will be given at the Annual General Meeting and conference in November.
- b) Realise funding through external funding applications, making savings through reorganisation.
- c) Upgrade the Fellowship's digital capacity, which means buying in new equipment, software, building a new website, developing our social media presence, and training staff.

# Trustees

The Fellowship is delighted to welcome David James as our newest trustee who brings a wealth of NHS and charity experience with him to his new role. David lives just north of Oxford and worked in education before having a career break and embarking on a new challenge within health care. He joined the former Commission for Health Improvement (CHI) which became the Health Care Commission (HCC) leaving before it morphed into the Care Quality Commission (CQC). Whilst at CHI, he was on the board of the North East Oxfordshire Primary Care Trust (PCT) as a non-executive director. He joined the NHS as a Board Secretary at Ealing Hospital in 2007. He went freelance in 2016 and has since worked as an interim Company Secretary or governance specialist in NHS trusts, Charities, NHS England and Clinical Commissioning Groups (CCGs).

He said his first impression of the Fellowship is "that it has got potential because of the nature of the NHS workforce - there are a significant number of older workers in the NHS and it is important that those individuals have the opportunity to join an organisation that will enhance their retired years."

His view of the top three priorities for the Fellowship are: " first, as is the same as all charities - facing the challenge of funding and income, the second is ensuring that the Fellowship has relevance for its membership and the third is to ensure that there is succession planning for the organisation so that ideas can be carried forward."

Serving as a Trustee is a very important way of supporting the NHSRF. The Board is currently seeking to recruit four new trustees, two from among the membership and two external trustees.
